- Main applicant must be 18 and above
- Meet the minimum investment criteria
- Police Clearance Certificate
- No critical health issues
- Appear for an interview during Antigua citizenship process
- Travel to Antigua for 5 day residency and Oath of Allegiance.

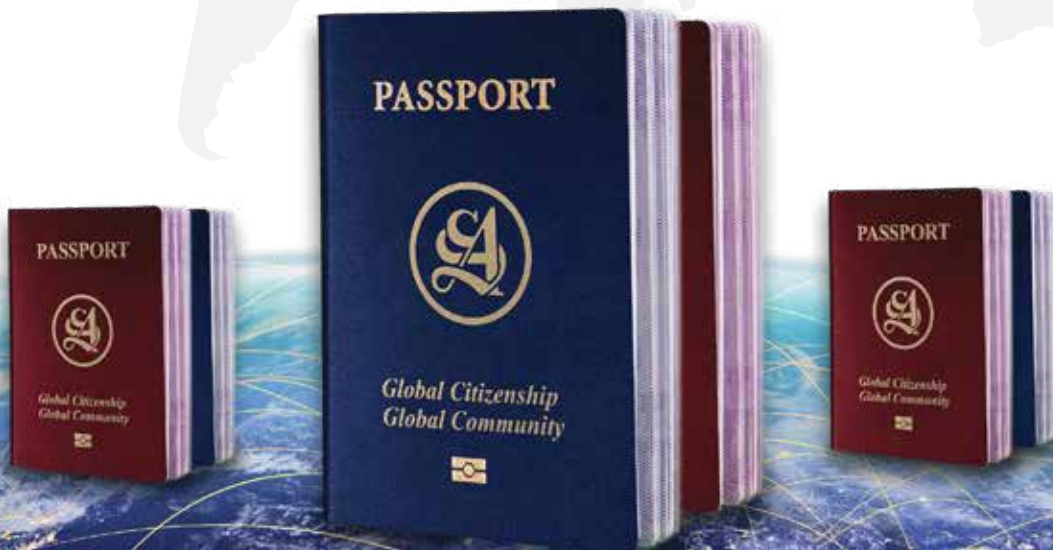
