



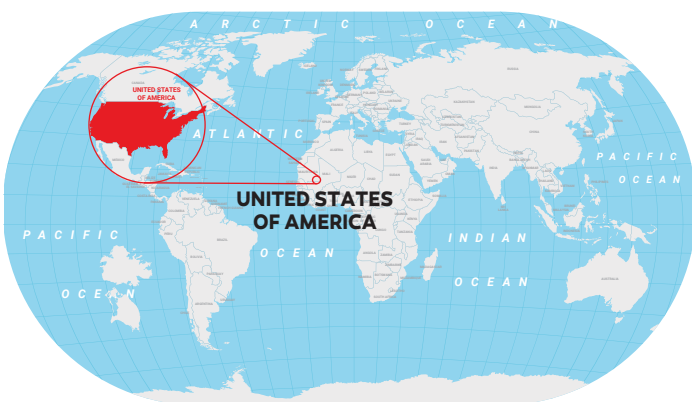

The USA E2 investor visa is a pathway for individuals from specific countries to invest in and actively operate a business in the United States. The E-2 visa is a special visa that allows the investor to invest in the US business, and based on this investment, the investor (Principal Applicant) can develop their business and bring spouse and children into the USA. To qualify for the E2 visa, you must meet specific criteria, including making a substantial capital investment and actively participating in managing the businesses. This non-immigrant visa is designed for investors, entrepreneurs, and those seeking to run a business in the United States. With the E2 visa, you can start a new business or invest in an existing one.

ELIGIBILITY REQUIREMENTS

- Must be national of a country which has an E-2 treaty
- Make a substantial investment (No set figure is associated with the investment.)
- Must have 50% ownership of the enterprise or possession of operational control through a managerial position or other corporate device.
- Sources of Funds must be declared and earned lawfully.
- Must have the intent to leave the country once the status is ended.
- The investment should not be made in marginal enterprises.

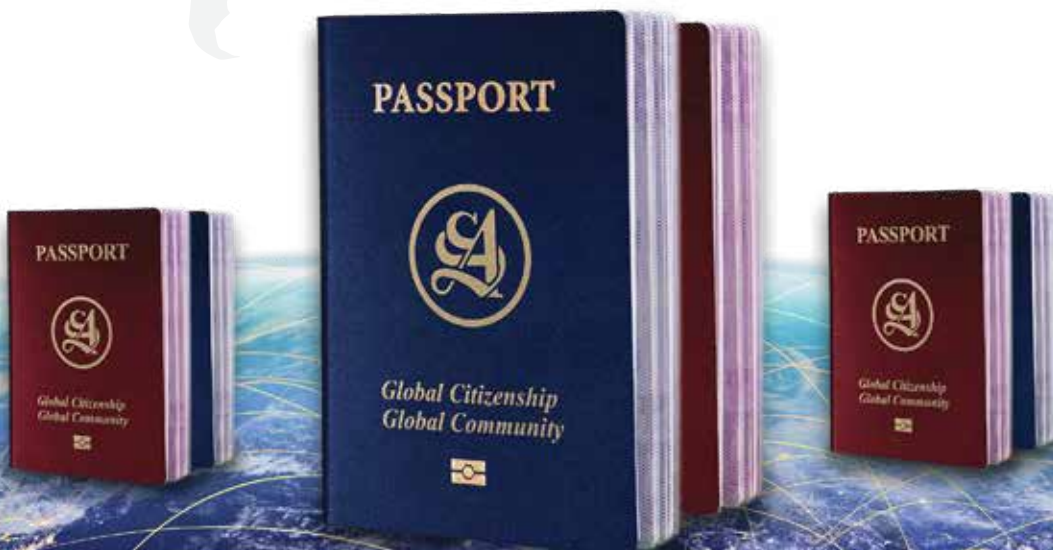
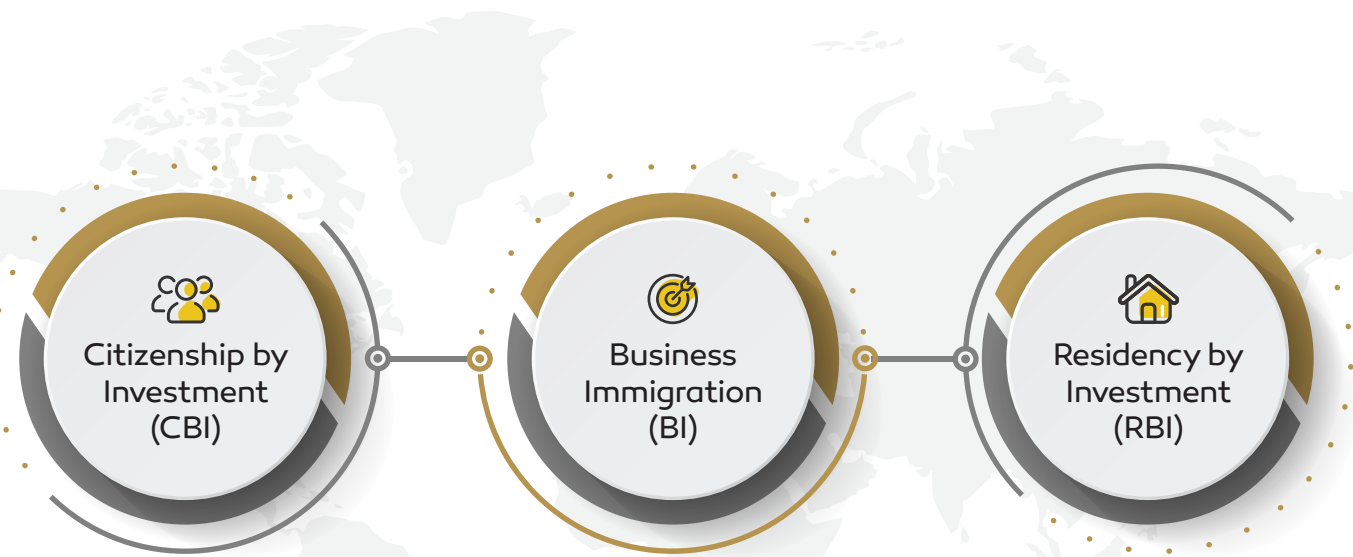
